I hope that you and your family are well. We return to Davis Park in the midst of our world trying to respond and come to grips with the COVID-19 pandemic. The 2020 season is beginning and we are fortunate that in spite of the pandemic, we have a group of skilled medical professionals available to assist us if the need should arise.

The Davis Park Medical Association facilitates this work by providing comfortable housing and an examination room for the medical team. Your *tax-deductible* dues and donations are critical to covering the cost of maintaining Bedside Manor.

Attached please find our **contribution form** and the 2019 financial statements. Membership remains at \$60.00 per household.

Please take a minute to fill out the contribution form and mail it along with your check to the address below. Additional donations are always appreciated. Donations of \$1000.00 or more are entitled to a remembrance plaque which hangs on the exterior of Bedside Manor.

In the past, coverage has been as follows: Full Weeks- June thru the beginning of September; and Weekends only- September thru mid-October. At this time, however, we are uncertain if there will be the same schedule of medical coverage as in past years. When we do have coverage, the protocols for Bedside Manor have been changed due to the impact of Covid-19. Medical staff will continue to be available to respond to emergencies on a 24/7 basis. However, traditional daily in-person office visits will not be available. Rather, during regularly scheduled office hours, for non-urgent issues doctors will be available for Telehealth consultations via iphone, Skype, Zoom, etc. For urgent issues that cannot be managed during regularly scheduled office hours, doctors will do Telehealth consultations. A more detailed schedule for Bedside Manor will be provided in the coming weeks.
